Strengthening the Capacity of Russian Rospotrebnadzor Specialists in the Area of Financial Literacy and Financial Consumer Protection.

Employer – Ministry of Finance of the Russian Federation with financial support of the World Bank.

Leontief Centre is consultant of the project in consortium Institute for Financial Planning (Moscow). The key objective of the Project is to establish the frameworks for the system of qualification upgrading and retraining of Rospotrebnadzor specialists to ensure effective implementation of financial consumer protection function through conducting urgent training of employees currently responsible for financial consumer protection. Rospotrebnadzor is the Federal Service for Control of Consumers Protection in Russia.

After the successful training sessions and international study tours aimed at the Rospotrebnadzor employees from central authorities and regional offices, the consultant consortium has provided

several analytical materials and recommendations on the development of the Rospotrebnadzor career development system. The project was successfully completed in November 2013.

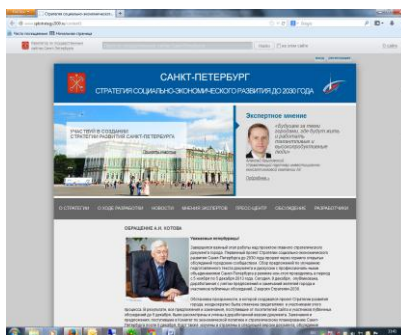


Elaboration of Project Strategy of Social and Economic Development of St Petersburg

To achieve the stated above purpose, Nordic-Russian Green Growth Arena project identifies three priority areas (sub-projects) under its umbrella:

- Green Planning Instruments and Strategies;
- Nordic-Russian Green Routes;
- Sustainable Business Hubs and Clean Tech Clusters



December 17 in St. Petersburg in the large conference hall of the Leontief Centre the seminar - dialogue "Green government procurement: the experience of the Baltic Sea Region (BSR) and the possibility of a new Russian legislation" was held under the Nordic Council of Ministers "Arena of green growth of Nordic Europe and North-West of Russia". The workshop was attended by experts Ecological Union of Sweden, who presented the results of the transnational project GREEN GOVERNMENT PROCUREMENT of Baltic region (www.balticgpp.eu), funded by the EU, with the participation of the Council of Baltic Sea States, CBSS-Baltic 21 and the European Union Strategy for

the Baltic Sea Region (EUSBSR). As a result of the Project formed a powerful platform for the promotion of best practices, legal frameworks and processes for green public procurement in the Baltic Sea. Also participated in the seminar project partners Nordic Council of Ministers' green growth Arena Nordic countries and Northwest Russia", representing the government and municipal management Pskov, Leningrad, Murmansk and Arkhangelsk regions, the Republic of Karelia and St. Petersburg. <http://arena.leontief-centre.ru/>



Project Sustainability and Effectiveness of Municipal Strategic Planning Systems: Empirical Study.

Project of a grant program of the Russian Foundation for the Humanities.

The project is a continuation of the work of 2012th.

The main results of R&D projects in 2013: analysis of the strategic planning technology expansion, based on 130 urban strategic planning documents; codification of 100 municipal strategic planning documents based on the classifier, allowing to characterize the proposed documents approaches to economics, social politics, infrastructure and strategy implementation tools; content analysis of the documents to differentiate focal strategy areas and a number of topics assigned by the federal level; analysis of the correlation between the socio-economic development of the city and availability of the working strategic plan (18 indicators of urban socio-economic development were chosen as dependent characteristics). Within the R&D activities a description of the Public Observatory of municipal strategies has been created as well.

The main objective of the project in St. Petersburg is the development of a technique of designing public spaces in the city as a comfortable, affordable and attractive to citizens, as well as their realization on the basis of the pilot municipalities.



Analysis of the Leningrad region influence on the current socio-economic development of St. Petersburg and the development of effective regional cooperation measures within border areas.

The object of the study has been devoted to the influence of Leningrad region on the socio-economic development of St. Petersburg. The work consisted of two stages: at first stage the main directions and characteristics of Leningrad region influence on the socio-economic development of the city have been established. Based upon these results, second phase of the project has come up with proposals on establishing effective interaction between two adjacent regions of the Russian Federation - St. Petersburg and the Leningrad region. Research was carried out in October-December 2013.

Developing responsible financial markets and the Financial Ombudsman Consumer Protection Service: UK experience and Rospotrebnadzor practices.

Employer - British Embassy.

The purpose of the Project is to build capacity of federal and regional authorities to implement Financial Ombudsman Service using the best practices from UK.

Main project activities: Analytical report on the role and functions of the Financial Ombudsman Service in relation to the financial markets and consumer protection in UK; Review of the Russian Government legal measures (Rospotrebnadzor in particular) and plans on implementation of the Financial Ombudsman Service in Russia; Expert Roundtable for federal and regional authorities highlighting the UK practice of the Financial Ombudsman Service (jointly with UK experts); Meeting of Rospotrebnadzor Advisory Board on consumer protection and Implementation of the Financial Ombudsman Service in Russia.

In the long-term perspective, creation of the Financial Ombudsman Service in Russia will contribute to the strengthening of the consumer rights protection, improve financial literacy and reinforce the development of the financial market, resolve disputes between consumers and businesses who provide financial services (banks, insurance and investment companies and financial advisors).

On November 19, 2013 the Agency for Strategic Initiatives in Moscow hosted an expert round table on "Judicial and non-judicial mechanisms to protect the rights and interests of consumers the financial services industry : international experience and the Russian practice".

During the roundtable there was discussed a new category of consumer claims - class action lawsuits, provided in the road map of the Russian Government on the development of competition, as well as the draft law prepared by the Ministry of Finance of the Russian Federation "On the financial ombudsman for consumers of financial services organizations."

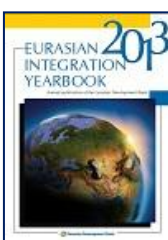
